

**'THE FINANCIAL INSTITUTIONS LAWS AMENDMENT
ORDINANCE, 1977**

ORDINANCE NO. LXI OF 1977

[30th December, 1977]

**An Ordinance to amend certain laws relating to
financial institutions.**

WHEREAS it is expedient to amend certain laws relating to
financial institutions for the purposes hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamations of
the 20th August, 1975, and the 8th November, 1975, and in
exercise of all powers enabling him in that behalf, the President
is pleased to make and promulgate the following Ordinance:-

Short title

1. This Ordinance may be called the Financial Institutions
Laws Amendment Ordinance, 1977.

2. The laws mentioned in column I of the Schedule shall be
amended in the manner indicated in column II thereof.

Savings

3. Any appointment of a General Manager in the Sangstha,
Bank or Corporation established by or under a law mentioned
in column I of the Schedule made by the Government at any
time before the promulgation of this Ordinance shall be deemed
to have been made under the relevant provision of such law, as
amended by this Ordinance, and every such appointment shall
have effect accordingly.

Article 26 shall be re-numbered as clause (1) of that Article, and-</p> <p>(a) in clause (1), as so re-numbered, <i>after</i> the words “The Bank may”, the commas, words, brackets and figure “, subject to the provisions of clause (2),” shall be <i>inserted</i>; and</p> <p>(b) <i>after</i> clause (1), amended as aforesaid, the following new clause shall be <i>added</i>, namely:-</p> <p style="padding-left: 40px;">“(2) Notwithstanding anything contained in clause (1), or in clause (1) of Article 38, the Government may appoint a General Manager of the Bank on such terms and conditions as it may determine.”.</p> <p>2. In Article 38, in clause (1), <i>after</i> the words, “The Bank may”, the commas and words “, subject to other provisions of this Order,” shall be <i>inserted</i>.</p>

Section 22 shall be re-numbered as sub-section (1) of that section, and-</p> <p>(a) in sub-section (1), as so re-numbered, <i>after</i> the words “The Corporation may”, the commas, words, brackets and figure “, subject to the provisions of sub-section (2),” shall be <i>inserted</i>; and</p> <p>(b) <i>after</i> sub-section (1), amended as aforesaid, the following new sub-section shall be <i>added</i>, namely:-</p> <p style="padding-left: 40px;">“(2) Notwithstanding anything contained in sub-section (1), the Government may appoint a General Manager of the Corporation on such terms and conditions as it may determine.”.</p>
